





STATEMENT

I, mr. Cornelis Adrianus de Zeeuw, civil-law notary ("notaris") practising in The Hague (the Netherlands), hereby state:

- according to the information appearing from the extract dated 13 January 2015 (the "Extract") from the Commercial Register of the Dutch Chamber of Commerce (the "Commercial Register"), Nederlandse Financierings-Maatschappij voor Ontwikkelingslanden N.V. is a public limited company under Dutch law ("naamloze vennootschap") having its registered office in The Hague (the Netherlands) and address at: (2593 HW) The Hague (the Netherlands), Anna van Saksenlaan 71, listed in the Commercial Register under number 27078545 (the "Company");

Reference is made to:

- the finance agreement between Kwamtili Estate Limited (the "Borrower") and Nederlandse Financierings-Maatschappij voor Ontwikkelingslanden N.V. ("FMO") dated 1 July 1974;
